

The quotation should conform to the following conditions:-

1. The rate quoted should be valid for a minimum period of 90 days from the due date of receipt of quotation.
2. Complete description, specification of the item(s) quoted should be given.
3. The point of supply such as Ex-works/FOR despatch station/ FOR destination, should clearly be indicated in the quotation.
4. Time required for effecting the supply / installation upon receipt of supply order should be indicated.
5. The rate of VAT/CST etc. if charged extra, should be indicated.
6. Warranty offered for the item(s) should be indicated. Warranty from the date of receipt of item(s)/date of installation of equipment, as the case may be, preferred.
7. Payment will be made only after satisfactory receipt of the Item(s) as ordered. No advance payment/part payment is admissible as per rules.
8. Quotation received after the due date will not be entertained.
9. The item(s) ordered should be supplied in a lot. Part supply will not be accepted.
10. The right to accept or reject the quotation rests with the Director, CPCRI.
11. EARNEST MONEY @ 2% of the total quoted amount must be deposited in cash or demand draft drawn in favour of "ICAR Unit, CPCRI, Kasaragod" on SBI, Kasaragod. Deposit at Call Receipt of the State Bank of India will also be accepted as earnest money provided the receipt obtained from the bank is attached with the quotation/tender. Remittance of EMD in any other mode is not acceptable TRANSIT INSURANCE: The purchaser will not pay separately for transit insurance and the supplier will be responsible until the entire stores contracted for arrive in good condition at destination
12. Performance security is to be remitted @ 10% of the value. Performance security may be furnished in the form of an Account Payee Demand Draft/ Fixed Deposit receipt from a commercial Bank/Bank Guarantee from a commercial Bank in an acceptable form(copy enclosed).The Performance Security should remain valid for a period of sixty days beyond the date of completion of the supply. The EMD will be refunded on receipt of Performance Security.
13. The buyer shall have the right to levy liquidated damages at a percentage not exceeding 10% per each month or part thereof in respect of supplies so delayed and delivered.
